‘Federal Health Agencies and the COVID Cartel: What Are They Hiding?’

Monday February 26, 2024: The below video was round table discussion by Sen. Ron Johnson about *“What Federal Health Agencies Aren’t Disclosing About COVID-19 Vaccines”* The panelist reveal the realities of Covid shots and the mRNA Gene Therapy dangers and the adverse effects on many of the public who took the shot. Summary

The transcript summarizes Senator Johnson’s opening statement at a public hearing titled **‘Federal Health Agencies and the COVID Cartel: What Are They Hiding?’**. He argues that the COVID pandemic opened his eyes to corruption and overreach by global

elites and health agencies. He details examples of withheld information, lack of transparency, suppression of dissenting voices, overhyped COVID fears, and conflicts of interest. The hearing aims to expose these issues, hold people accountable, and prevent future tragedies. Speakers with 'opened eyes' will challenge official narratives on topics like early treatment, vaccine safety, and pandemic policy harms.

Introduction and Hearing Purpose

Senator Johnson welcomes participants and media, quoting Brandeis on open discussion countering falsehoods. He argues COVID opened his eyes to global elite corruption, information control, and narrative pushing while marginalizing dissent. The hearing will expose truth and pursue accountability.

Real-World Tragedy Prompting Event

A 36-year old woman had menstrual issues after her second COVID vaccine, likely meaning she cannot have children. This tragedy sums up the hearing goal of exposing truth and preventing recurrences by making responsible parties pay and instituting safeguards.

Examples of Secrecy and Stonewalling

Senator details multiple examples of federal agencies not releasing requested information on topics like Fauci emails, COVID vaccine lot analyses, and VAERS data mining techniques. After months or years of requests and narrowing, documents still remain hidden without clear reasons.

Rationale for Pursuing Truth

The Senator argues true scientific inquiry requires challenging assumptions with skepticism and humility. Much knowledge remains undiscovered and human understanding is bounded. Health agency trust has declined so truth and accountability are essential to repair damage.

Event Speaker Backgrounds

Speakers have diverse backgrounds but share the common attribute of opened eyes, refusing to let them be closed again. They will challenge official pandemic narratives on issues like vaccines, early treatment, data transparency, and policy impacts.

Excerpt of Talk – Why Redacted FOIA Request

They will not release these. We have spent now going close to two years; this is what has been provided to us. ***Do you think there might be some incriminating information in this?***

Now again, these are government documents. This is government federal records. This should be made available to... Congress, this should be made available to the American public, but it is not. So, that's the Fauci emails. My letters are on hot-lots, I've written four of them, starting in December of 2021. ***(see videos below)***
